www.dancingclassrooms.com provides this Privacy Policy to detail our handling of your personal information. By using the site, you agree to the terms of this Privacy Policy, and therefore you should review its terms. We obtain details from your computer each time you use our site. The information we obtain can be personal in nature, and therefore the following policy is provided to clarify our procedures for carefully handling this information. USE AND DISCLOSURE OF PERSONAL INFORMATION BY DANCING CLASSROOMS:

The term "Personal Information" as used in this Privacy Policy refers to your name, home or other address, e-mail addresses, telephone numbers, or other information which identifies you as an individual. Our web site may use various forms for users to request information, register with the site, make donations, purchase products and use our services. We may collect contact information (such as your e-mail address, name, address and phone number) and financial information (such as credit card numbers and your billing address) through these forms. The details from the forms are used to send information about our programs, events, products or services, and to help us maintain our records. You can change your user information at any time, and we encourage you to keep it up to date.

We reserve the right to collect and disclose (to our affiliates and to non-affiliate third parties) user behavior and Personal Information to the extent permitted by applicable law or as specifically restricted below or in the [Terms of Use](#) (click to link). We may place a text file called a "cookie" in the browser files of your computer. The cookie itself does not contain Personal Information although it enables us to collect information about your visits to our website. We may use this information to enhance your website experience and may share some information with our members, vendors, sponsors or others.

We reserve the right at all times to disclose any information as necessary to satisfy any applicable law (including, without limitation, the Children's Online Privacy Protection Act), regulation, legal process, demands by parties claiming your infringement of their rights or governmental request, or to edit, refuse to post or remove any information or materials, in whole or in part, in our sole discretion.

We encourage you to use caution and common sense in giving out Personal Information when using our website and any services provided through our website. We have no control over third parties to whom you may give Personal Information through the use of our website.

THE ABILITY TO OPT-OUT

We may send you e-mail updates or a newsletter featuring information about us, our programs, products, and services which we think may be of interest to you. USE OF COOKIES ON THIS SITE

We attempt to provide you with information, programs, products, contests, offers, and services that meet your needs and desires. We use cookies (small computer files that stay on your computer and let us know when and how often you visit our site) to keep and track our information about you. DANCING CLASSROOMS'S USER SURVEYS AND POLLS

INFORMATION FOR CHILDREN UNDER 13 OR PARENTS OF CHILDREN UNDER 13

In compliance with the Children's Online Privacy Protection Act (COPPA), we do not intend to collect any Personal Information from children under 13 years of age.
